## MINUTE RECORD FOR CITY OF ALMA REGULAR CITY COUNCIL MEETING January 20, 2021

A meeting of the City Council of the City of Alma, Nebraska was held at City Hall on Wednesday, the 20th of January, 2021, at 5:30 p.m.

Present were Council Members: Larry Casper, Dyann Collins, Tom Moulton, Chris Tripe and Mayor Hal Haeker. Administrator Doug Wilson, City Attorney Doug Walker, Treasurer Lorri Bantam, Clerk Jessica Miller, Jennie Kozal with Miller & Associates and Angie Bellware were also in attendance. Notification of this meeting and the agenda was given in advance by posting, a designated method for giving notice. Advance notice of the meeting and the agenda were given to the Mayor and all members of the City Council. All proceedings hereinafter were taken while the convened meeting was open to the attendance of the public.

Mayor Haeker advised the public of the Open Meetings Act which is posted on the east wall of the meeting room, and then proceeded to call the regular meeting of January 20, 2021, at 5:30 p.m. and the following business was transacted:

Roll call: Larry Casper-present, Dyann Collins-present, Tom Moulton-present, Christopher Tripe-present and Mayor Haeker-present. Motion made by Casper, second by Moulton to determine this meeting as previously publicized, duly convened and in open session. There being no further discussion upon the motion made and upon roll call vote, the following voted yes: Casper, Moulton, Collins and Tripe. Voting no: None. Motion carried.

Mayor opened the floor to approve the minutes of the January 6, 2021, regular council meeting. Motion made by Moulton, second by Collins to approve the January 6, 2021 minutes, as presented. There being no further discussion upon the motion made and upon roll call vote, the following voted yes: Moulton, Collins, Casper and Tripe. Voting no: None. Motion carried.

Mayor opened the floor to discuss the claims and invoices for period January 7, 2021 through January 20, 2021 for a total of \$96,550.51. Motion by Moulton, second by Collins to approve the claims and invoices for period January 7, 2021 through January 20, 2021 for a total of \$96,550.51. Mayor opened the floor to consider/approve the City Auditorium improvement feasibility study. Jennie Kozal with Miller & Associates presented the finished feasibility study. The next step will be to secure funding and apply for the construction portion of the CCCFF grant program. Motion by Tripe, second by Moulton to approve the finished City Auditorium feasibility study. There being no further discussion upon the motion made and upon roll call vote, the following voted yes: Tripe, Moulton, Casper and Collins. Voting no: None. Motion carried.

Mayor opened the public hearing at 6:11 p.m. to make a recommendation to the state liquor control commission to approve or deny Los Primos Mexican Grill LLC application for Class C liquor license. Motion by Tripe, second by Casper to close the public hearing at 6:12 p.m. There being no further discussion upon the motion made and upon roll call vote, the following voted yes: Tripe, Casper, Collins and Moulton. Motion carried. Motion by Tripe, second by Collins to make a recommendation to the state liquor control commission to approve Los Primos Mexican Grill LLC application for Class C liquor license. There being no further discussion upon the motion made and upon roll call vote, the following voted yes: Tripe, Collins, Casper and Moulton. Voting no: None. Motion carried.

## ORDINANCE; AND TO DECLARE AN EFFECTIVE DATE.

And moved that the statutory rule requiring reading on three different dates be suspended.
